There will be a ~10-minute break between .22 and Centerfire, and a ~30-minute lunch break between Centerfire and .45 aggregate matches.

Food/Beverages: There are no food establishments near the range.

Grilled burgers and hotdogs will be included in your match fees.

If you do not want the provided food, please bring your own meals/snacks.

Use of alcohol before or during match is forbidden. No alcoholic beverages or empty alcoholic beverage containers are permitted on the club premises. Violators will be disqualified from competition, required to leave the premises immediately, and forbidden to compete in future club events.

Competitors must provide their own staplers, clipboards, tape or pasters.

Course of Fire: All slow fire will be fired at 50 yards on B-6 targets; timed and rapid fire at 25 yards on B-8 targets. The range is equipped with turning targets at 25 yards.

Match #1: .22 Slow Fire (20 shots)
Match #2: .22 National Match Course (30 shots)
Match #3: .22 Timed Fire (20 shots)
Match #4: .22 Rapid Fire (20 shots)
Match #5: .22 Aggregate
Match #6-10: Same as 1-5, except caliber is Centerfire
Match #11-15: Same as 1-5, except caliber is .45
Match #16: Grand Aggregate

Match Fees: A \$10 gate fee will be added to the below match fees if you are not a club member:

*Due to limited space, priority will be given to full 2700 shooters

Awards: One open winner per match, Class awards for each classification. Open winner not eligible for Class awards. Classes may be combined upwards, however, shooters will not be combined with High Masters.

After match expenses, 50% of entry fees will be returned to competitors in awards and a percentage will go toward the SC State Championship award fund.

.22-only 2700 competitors will be eligible for awards in .22 stages **ONLY**, UNLESS there is a minimum of three (3) competitors shooting .22-only matches.
