Match day: Check-in begins at 08.30; the first shot will be fired at 0900 SHARP

There will be a ~10-minute break between .22 and Centerfire, and a ~30-minute lunch break between Centerfire and .45 aggregate matches.

Food/Beverages: There are no food establishments near the range. Please bring your own food. We will have ice water and snacks available.

2025 CMP Match Pistol Rules and classifications will be utilized.

Use of alcohol before or during match is forbidden. No alcoholic beverages or empty alcoholic beverage containers are permitted on the club premises. Violators will be disqualified from competition, required to leave the premises immediately, and forbidden to compete in future club events.

Competitors must provide their own staplers, clipboards, tape or pasters.

Course of Fire: All slow fire will be fired at 50 yards on B-6 targets; timed and rapid fire at 25 yards on B-8 targets. The range is equipped with turning targets at 25 yards.

Match #1: .22 Slow Fire (20 shots)
Match #2: .22 National Match Course (30 shots)
Match #3: .22 Timed Fire (20 shots)
Match #4: .22 Rapid Fire (20 shots)
Match #5: .22 Aggregate
Match #6-10: Same as 1-5, except caliber is Centerfire
Match #11-15: Same as 1-5, except caliber is .45
Match #16: Grand Aggregate
